
ORDER TO SHOW CAUSE

ORDERED as follows:

1. That CMI, Inc. of Kentucky, shall appear before the Honorable Phyllis R. Galen at the Judge Lynn N. Silvertooth Judicial Center, 2002 Ringling Boulevard, Sarasota, Florida 34237 on the 18th day of July, 2007, at the hour of 3:00 P.M., Courtroom 2A, to show cause why it should not be held in Contempt of Court.
2. This Court is aware of the Order Quashing Subpoenas, by the Daviess District Court in Kentucky, 07-C-00691; what legal effect, in any, this court must give to this order may be addressed at the Show Cause hearing.
3. It is further Ordered that the Sheriff of Broward County, Florida or his designee, is directed to served a copy of the Order on CMI Inc. of Kentucky, by serving its registered agent, NRAI Services, Inc., 2731 Executive Park Drive, Suite 4, Weston, FL 33331.
